RESOLUTION NO. 23-432

RESOLUTION GRANTING GRATUITY PAY TO CONTRACT OF SERVICE (COS) AND JOB ORDER (JO) WORKERS IN THE TOTAL AMOUNT OF NINE MILLION SIX HUNDRED SEVENTY-FIVE THOUSAND PESOS (PHP9,675,000.00), TO BE TAKEN FROM THE SAVINGS OF PERSONAL SERVICES AND MAINTENANCE AND OTHER OPERATING EXPENSES FOR CY 2023 AS STIPULATED IN RESOLUTION NO. 2, SERIES OF 2023 OF THE LOCAL FINANCE COMMITTEE, BAGO CITY.

WHEREAS, in an Indorsement letter dated December 18, 2023, from the Honorable City Mayor, respectfully referred to this Honorable body, Resolution No. 2, series of 2023 of the Local Finance Committee, this City, for approval;

WHEREAS, the grant of the one-time Gratuity Pay to Contract of Service and Job Order workers, not exceeding P3,000.00 per person, shall be subject to the following conditions:


1. The COS and JO workers have rendered a total or an aggregate of at least four (4) months of actual satisfactory performance of service, as stipulated in their respective contracts, as of December 15, 2023;
2. The contracts of the COS and JO workers are still effective as of December 15, 2023;
3. Those who have rendered less than four (4) months of actual satisfactory performance of service, as stipulated in their respective contracts, as of December 15, 2023, and whose contracts are still effective as of same date, shall be granted the Gratuity Pay, on a pro rata basis, as follows:

Length of Service	Amount of Gratuity Pay
3 months but less than 4 months	Not exceeding P2,400.00
2 months but less than 3months	Not Exceeding P1,800.00
Less than 2 months	Not Exceeding P1,200.00



RESOLVES, as it is hereby resolved, to grant Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers in the total amount of Nine Million Six Hundred Seventy-Five Thousand Pesos (Php9,675,000.00), to be taken from the Savings of Personal Services and Maintenance and Other Operating Expenses for CY 2023 as stipulated in Resolution No. 2, series of 2023 of the Local Finance Committee, Bago City.
