
WHEREAS, the said Contracts of Services shall be done every 6 months not exceeding 2 renewals for the year 2024 when the services are needed by the City Government;

WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.


