RESOLUTION APPROVING RESOLUTION NO. 2, SERIES OF 2023 OF THE GENDER AND DEVELOPMENT COUNCIL, BAGO CITY, ENTITLED: "RESOLUTION APPROVING THE REPROGRAMMING OF SEVEN HUNDRED THOUSAND PESOS (₱700,000.00) FROM CAPITAL OUTLAY TO MOOE OF "OPERATION OF BAGO CITY CRISIS CENTER FOR WOMEN AND CHILDREN" AND REPROGRAMMING OF TWO HUNDRED FIFTY THOUSAND PESOS (₱250,000.00) FROM CAPITAL OUTLAY TO MOOE OF "SKILLS TRAINING & LIVELIHOOD GRANT TO WOMEN AND THEIR INDIGENT FAMILIES, AND REPROGRAMMING OF TWO MILLION ONE HUNDRED THOUSAND PESOS (₱2,100,000.00) FROM "SAFE HEALTHY MATERNAL AND NEW BORN PROGRAM (F1K PROGRAM)" TO ENHANCED MALE FAMILY PLANNING PROJECT".
