

WHEREAS, after a thorough deliberation on the matter, this August Body is of the consensus to approve said Resolution;


NOW, THEREFORE, upon motion of SP Member Marina Javellana-Yao, unanimously seconded by SP Members present, the Sangguniang Panlungsod
