RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BAGO AND CARESPAN ASIA, INC., IN THE IMPLEMENTATION OF DIGITAL HEALTH PLATFORM.

WHEREAS, in a letter dated April 11, 2023, from the Honorable City Mayor, and addressed to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City Government of Bago and CARESPAN ASIA, INC., in the implementation of Digital Health Platform;

WHEREAS, this August body likewise is giving authority to the Honorable City Mayor to sign in the renewal of the contract if the same is deemed needed by the City;

WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.
