RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE BUREAU OF FIRE PROTECTION, REGION 6 (BFP), IN RELATION TO THE ON-THE-JOB TRAINING OF THE BAGO CITY COLLEGE CRIMINOLOGY STUDENTS ON THE FOUR (4) DIFFERENT FIRE STATIONS IN THE PROVINCE OF NEGROS OCCIDENTAL.

WHEREAS, in a letter dated April 14, 2023, from the Honorable City Mayor, and addressed to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Bureau of Fire Protection, Region 6 (BFP), in relation to the On-the-Job Training of the Bago City College Criminology students on the four (4) different fire stations in the province of Negros Occidental;
