RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF BAGO AND THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD), IN THE IMPLEMENTATION OF PAMBANSANG PABAHAY PARA SA PILIPINO (4PH) PROGRAM.

WHEREAS, in a letter dated April 14, 2023, from the Honorable City Mayor, and addressed to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Understanding between the City of Bago and the Department of Human Settlements and Urban Development (DHSUB), in the implementation of Pambansang Pabahay Para sa Pilipino (4PH) Program;
