RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BAGO AND THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL IN RELATION TO THE IMPLEMENTATION OF THE UNIVERSAL HEALTH CARE SYSTEMS.


WHEREAS, in a letter dated May 8, 2023, from the Honorable City Mayor and addressed to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City Government of Bago and Provincial Government of Negros Occidental in relation to the implementation of the Universal Health Care Systems;

WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.


