**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A DEED OF DONATION BETWEEN THE CITY GOVERNMENT OF BAGO AND VALERINO FAJARDO, ROSEMARIE FAJARDO, RAYMOND JESUS FAJARDO, AND BRENDA FAJARDO, IN FAVOR OF THE CITY OF BAGO OVER A PORTION OF A PARCEL OF LAND LOCATED AT HANAO-HANAO, BARANGAY CARIDAD, BAGO CITY, NEGROS OCCIDENTAL, AS A SITE FOR THE HANAO-HANAO DAY CARE CENTER WITH AN AREA OF TWO HUNDRED FIFTY (250) SQUARE METERS, MORE OR LESS, AND LIKewise THANK THE DONORS FOR THEIR BENEVOLENT ACT TOWARDS THE RESIDENTS THEREAT.**

**WHEREAS**, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.


