RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND MAILUM ORGANIC VILLAGE ASSOCIATION (MOVA) IN RELATION TO THE IMPLEMENTATION OF REPUBLIC ACT 8435 (AGRICULTURE AND MODERNIZATION ACT) WHEREIN THE CITY WOULD MAKE AVAILABLE THE FOLLOWING AGRICULTURAL EQUIPMENT FOR THE USE OF THE SAID ASSOCIATION, TO WIT:

1. 2 UNITS PUMP SET;
2. 1 UNIT BOWA MINI RICE MILL AND
3. UNITS FLOATING TILLER.



WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.


