RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BAGO INTEGRATED FARMERS ASSOCIATION (BIFA) IN RELATION TO THE IMPLEMENTATION OF REPUBLIC ACT 8435 (AGRICULTURE AND MODERNIZATION ACT) WHEREIN THE CITY WOULD MAKE AVAILABLE AGRICULTURE EQUIPMENT (1 UNIT BOWA RICE MILL) FOR THE USE OF THE SAID COOPERATIVE.

WHEREAS, in a letter dated June 5, 2023, from the Honorable City Mayor and addressed to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement to be executed by and between the City Government of Bago and Bago Integrated Farmers Association (BIFA) in relation to the implementation of Republic Act 8435 (Agriculture and Modernization Act) wherein the City would make available agriculture equipment (1 unit BOWA Rice Mill) for the use of the said Cooperative.;

WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.
