RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, PROVINCE OF NEGROS OCCIDENTAL, CITY OF LA CARLOTA, CITY OF HIMAMAYLAN, CITY OF SAN CARLOS, MUNICIPALITY OF ISABELA, MUNICIPALITY OF LA CASTELLANA, MUNICIPALITY OF PONTEVEDRA, MUNICIPALITY OF MOISES PADILLA, MUNICIPALITY OF BINALBAGAN, MUNICIPALITY OF HINIGARAN, REGIONAL DEVELOPMENT COUNCIL OF THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY, NATIONAL IRRIGATION ADMINISTRATION, THE NATIONAL COMMISSION ON INDIGENOUS PEOPLES, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, AGRICULTURE, DEPARTMENT DEPARTMENT OF OF AGRARIAN REFORM, PEOPLES ORGANIZATIONS/INDIGENOUS PEOPLES ORGANIZATIONS, AND PHILIPPINE ASSOCIATION OF WATER DISTRICTS, IN RELATION TO THE CREATION OF TANOLO WATERSHED MANAGEMENT COUNCIL.

WHEREAS, letter dated June 16, 2023, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Agreement between the City of Bago, Department of Environment and Natural Resources, Province of Negros Occidental, City of La Carlota, City of Himamaylan, City of San Carlos, Municipality of Isabela, Municipality of La Castellana, Municipality of Pontevedra, Municipality of Moises Padilla, Municipality of Binalbagan, Municipality of Hinigaran, Regional Development Council of the National Economic Development Authority, National Irrigation Administration, The National Commission on Indigenous Peoples, Department of Public Works and Highways, Department of Agriculture, Department of Agrarian Reform, Peoples Organizations/Indigenous Peoples Organizations, and Philippine Association of Water Districts, in relation to the creation of Tanolo Watershed Management Council;

WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on said request.
