RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF UNDERSTANDING BETWEEN THE BAGO CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL AND JIASHEM WATER REFILLING STATION IN THE IMPLEMENTATION OF REPUBLIC ACT 10121.

WHEREAS, letter dated June 13, 2023, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in the Memorandum of Understanding between the Bago City Disaster Risk Reduction and Management Council and Jiashem Water Refilling Station in the implementation of Republic Act 10121;
