**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A DEED OF DONATION BETWEEN THE CITY GOVERNMENT OF BAGO AND THE PHILIPPINE NATIONAL POLICE (BAGO CITY) WHEREIN THE CITY SHALL BUY AND DONATE EIGHT (8) UNITS ASSAULT RIFLES (SYSTEMS DEFENSE R56 ASSAULT RIFLE) TO THE BAGO CITY POLICE STATION.**

**WHEREAS**, in a letter dated September 12, 2023, from the Honorable City Mayor, and addressed to this Honorable body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Deed of Donation between the City Government of Bago and Philippine National Police (Bago City) wherein the City shall buy and donate eight (8) units Assault Rifles (Systems Defense R56 Assault Rifle) to the Bago City Police Station;
