RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A DEED OF DONATION BETWEEN THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) AND THE CITY OF BAGO, WHEREIN THE FORMER DONATED TO THE CITY THREE THOUSAND (3,000) NON-FOOD PACKS FOR DISTRIBUTION TO THE RESIDENTS OF THE CITY.
