RESOLUTION NO. 23-381

RESOLUTION FAVORABLY ENDORSING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, 4th ENGINEERING DISTRICT OF NEGROS OCCIDENTAL PROPOSED ROAD CONVERSION FROM A LOCAL ROAD INTO A NATIONAL ROAD ACQUIRING A ROAD NAME AS JUNCTION SUM-AG – ABUANAN NATIONAL ROAD – TABUNAN BAGO CITY – CABUG DIVERSION ROAD WITH POINT OF ORIGIN AT BARANGAY TABUNAN, BAGO CITY DISTRICT JAIL (BJMP-MALE DORMITORY) TO BOUNDARY OF BARANGAY TABUNAN, BAGO CITY AND BARANGAY CABUG, BACOLOD CITY VIA CIRCUMFERENTIAL ROAD TO SILAY-BACOLOD AIRPORT.

WHEREAS, in an endorsement letter dated October 23, 2023, from the Honorable City Mayor, respectfully referred to this Honorable body, a communication from Engr. Genero M. Panganiban, District Engineer, DPWH, the proposed road conversion from a Local Road into a National Road acquiring a road name as Junction Sum-ag – Abuanan National Road – Tabunan Bago City – Cabug Diversion Road with point of origin at Barangay Tabunan, Bago City District Jail (BJMP-Male Dormitory) to boundary of Barangay Tabunan, Bago City and Barangay Cabug, Bacolod City via Circumferential Road to Silay-Bacolod Airport;

WHEREAS, this has a total road length of 1.935 kilometers and this diversion road leads to a tourist destination or government structure facilities;

NOW, THEREFORE, upon motion of SP Member Carlos E. Mondia, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to favorably endorse the Department of Public Works and Highways, 4th District of Negros Occidental proposed road conversion from a Local Road into a National Road acquiring a road name as Junction Sum-ag – Abuanan National Road – Tabunan Bago City – Cabug Diversion Road with point of origin at Barangay Tabunan, Bago City District Jail (BJMP-Male Dormitory) to boundary of Barangay Tabunan, Bago City and Barangay Cabug, Bacolod City via Circumferential Road to Silay-Bacolod Airport.
