RESOLUTION AMENDING RESOLUTION NO. 23-374 TO READ AS FOLLOWS: "RESOLUTION FAVORABLY ENDORSING THE COMMERCIAL SAND AND GRAVEL (CSAG) PERMIT OF MR. FIDEL T. HENARES, WITH AN AREA OF 1.7145 HECTARES OVER A PORTION OF MARAGANDANG RIVER AT BARANGAYS MA-AO AND DON JORGE L. ARANETA, BOTH OF THIS CITY".

WHEREAS, in a letter dated October 25, 2023, from Mr. Vicente Mesias, City ENRO, noted by the Honorable City Mayor and favorably endorsed to this Honorable body, the request for amendment of Resolution No. 23-374, relative to the quarry application of Mr. Fidel T. Henares at Barangays Don Jorge L. Araneta and Ma-ao with an area of 1.7145 hectares which previous request was erroneously written as Industrial Sand and Gravel (ISAG) where it should have been a Commercial Sand and Gravel Quarry Project;
