RESOLUTION NO. 23-017

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE BUREAU OF FIRE PROTECTION (BFP), IN RELATION TO THE ESTABLISHMENT OF MA-AO FIRE SUB-STATION AND USE OF THE EXISTING BUILDING LOCATED AT BARANGAY MA-AO, BAGO CITY, NEGROS OCCIDENTAL, KNOWN AS THE "PROJECT".

WHEREAS, letter dated January 9, 2023, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Bureau of Fire Protection (BFP);

WHEREAS, this Memorandum of Agreement is intended for the establishment of Ma-ao Fire Sub-Station and use of the existing Building located at Barangay Ma-ao, Bago City, Negros Occidental, known as the "PROJECT";

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request.
