RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE BAGO CITY FEDERATION OF COFFEE GROWERS, INC. AS PART OF THE FINANCIAL ASSISTANCE TO THE COFFEE FARMERS ENTREPRENEURSHIP PROJECT.

WHEREAS, letter dated January 9, 2023, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Bago City Federation of Coffee Growers, Inc. as part of the financial assistance to the coffee farmers entrepreneurship project;

WHEREAS, this matter was referred to the Committee on Agriculture, which recommended favorably the grant of said authority provided that the true figure in SP Resolution No. 22-288 in the amount of ₱754,062.00 must be reflected in the amended Memorandum of Agreement;

WHEREAS, after a thorough deliberation on the matter, it is of the consensus of this Honorable body to adopt the recommendation of the Committee;

NOW, THEREFORE, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to authorize the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Bago City Federation of Coffee Growers, Inc. as part of the financial assistance to the coffee farmers entrepreneurship project.
