LIKewise, TO AUTHORIZE HIM TO SIGN FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE RENEWAL OF THE CONTRACT OF SERVICES WITH THE IDENTIFIED PARTY WHEN THE SAME IS NEEDED BY THE CITY GOVERNMENT.
