**RESOLUTION EXTENDING THE PERIOD OF THE DEADLINE FOR THE RENEWAL OF BUSINESS PERMIT AND MOTORIZED TRICYCLE OPERATOR'S PERMIT AND OTHER PERMITS AND LICENSES IMPOSED BY THE CITY UNDER THE REVISED LOCAL REVENUE CODE OF 2017 TO JANUARY 31, 2023.**

**WHEREAS**, in an endorsement letter dated January 24, 2023, from the Honorable City Mayor, respectfully referred to the Honorable Members, Sangguniang Panlungsod, this City, a communication from Mr. Caruso T. Villaflor, Jr., City Treasurer, also of this City, requesting from this Honorable body for the passage of a resolution extending the period of the deadline for the Renewal of Business Permit and Motorized Tricycle Operator's Permit and Other Permits and Licenses imposed by the City under the Revised Local Revenue Code of 2017 to January 31, 2023;

**WHEREAS**, this extension is due to the influx of taxpayers and requests to be given ample time to secure permits from various agencies;


**WHEREAS**, the extension of the deadline is retroactive on January 21, 2023;
