RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2022-010 OF BARANGAY MAILUM, BAGO CITY, ENTITLED: "AN ORDINANCE MANDATING THE STRICT IMPLEMENTATION OF CURFEW HOURS FOR CHILDREN FROM 10:00 O'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, PRESCRIBING THE PROPER PROCEDURE FOR THEIR APPREHENSION AND CUSTODY PURSUANT TO REPUBLIC ACT NO. 9344, OTHERWISE KNOWN AS THE JUVENILE JUSTICE AND WELFARE ACT OF 2006, AS AMENDED, AND FOR OTHER PURPOSES".

WHEREAS, a letter from the Punong Barangay of Barangay Mailum, Bago City, addressed to this Honorable body, the request for the approval of Barangay Ordinance No. 2022-010;

WHEREAS, after a thorough deliberation on the matter, it was the consensus of this Honorable Body to approve the said Barangay Ordinance.
