RESOLUTION AUTHORIZING THE CITY TREASURER TO CLOSE AND TRANSFER OUR 2 ACCOUNTS FROM LANDBANK OF THE PHILIPPINES-BACOLOD BRANCH TO LANDBANK OF THE PHILIPPINES-BAGO AGRI HUB BEARING ACCOUNT NAMES BAGO CITY HOSPITAL (FACILITY) AND BAGO CITY HOSPITAL (PERSONNEL) WITH ACCOUNT NUMBERS 0422-1271-94 AND 0422-1272-08, RESPECTIVELY, LIKewise, AUTHORIZING THE RE-ACTIVATION, CLOSURE AND TRANSFER OF BAGO CITY HEALTH OFFICE (PROFESSIONAL) AND BAGO CITY HEALTH OFFICE (HCI CHARGES) BEARING ACCOUNT NUMBERS 0422-1312-80 AND 0422-1312-99, RESPECTIVELY, FROM LANDBANK OF THE PHILIPPINES-BACOLOD BRANCH TO LANDBANK OF THE PHILIPPINES-BAGO AGRI HUB.

WHEREAS, letter dated January 30, 2023, from the Acting City Mayor, Honorable Ramon D. WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request.

NOW, THEREFORE, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sangguniang Panlungsod
