

WHEREAS, after a thorough deliberation on the matter, it was the consensus of this Honorable Body to favorably act on said request;


NOW, THEREFORE, on the motion of SP Member Carlos E. Mondia, unanimously seconded by SP members present, the Sangguniang Panlungsod
