RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A DEED OF DONATION BY THE DEPARTMENT OF HEALTH WESTERN VISAYAS-CENTER FOR HEALTH DEVELOPMENT TO THE CITY OF BAGO OF ONE (1) UNIT AMBULANCE INCLUDING EQUIPMENT AMOUNTING TO TWO MILLION FIFTEEN THOUSAND PESOS (P2,015,000.00), IN THE IMPLEMENTATION OF UNIVERSAL HEALTH CARE.

WHEREAS, letter dated February 9, 2023, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Deed of Donation by the Department of Health Western Visayas-Center for Health Development to the City of Bago of one (1) unit ambulance including equipment amounting to Two Million Fifteen Thousand Pesos (P2,015,000.00), in the implementation of Universal Health Care;
