RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN AN AGREEMENT ON ACADEMIC COOPERATION BETWEEN THE BAGO CITY COLLEGE AND TOKINAWA UNIVERSITY OF JAPAN, IN RELATION TO THE EXCHANGE OF ACADEMIC EXPERTISE OF BOTH SCHOOLS.

WHEREAS, letter dated February 20, 2023, from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in an Agreement on Academic Cooperation between the Bago City College and Tokinawa University of Japan, in relation to the exchange of academic expertise of both schools;
