RESOLUTION NO. 23-082

RESOLUTION ESTABLISHING THE BAGO CITY HEALTH OFFICE AND ITS APPLICATION FOR DEPARTMENT OF HEALTH-PERMIT TO CONSTRUCT (DOH-PTC) AND DEPARTMENT OF HEALTH LICENSE-TO-OPERATE OF A PRIMARY CARE FACILITY (LTO PCF) ACCREDITATION AND LICENSING THRU THE HEALTH FACILITIES AND SERVICES OF THE DEPARTMENT OF HEALTH.

WHEREAS, Section 27.b of the Universal Health Care (UHC) Act or Republic Act (RA) No. 11223 states that, "The DOH shall institute a licensing and regulatory system for stand-alone health facilities, including those providing ambulatory and primary care services, and other modes of health service provision";

WHEREAS, the DOH, through the Health Facilities and Services Regulatory Bureau (HFSRB) and Center for Health Development Regulation Licensing and Enforcement Division (CHD-RLEDs) already regulates stand-alone health facilities providing ambulatory services such as birthing homes, infirmaries, and other;

WHEREAS, as listed in the 2020 National Health Facility Registry, there are 2,592 Rural Health Units (RHUs) classified as Primary Care Facilities (PCFs) and are currently not being regulated by DOH. These PCFs shall deliver initial contact, accessible, continuous, comprehensive, and coordinated care to the communities they serve, as envisioned in the UHC Act. Thus, to fulfill the UHC goals of ensuring that only safe and quality primary care services are being delivered to every Filipino, PCFs will now be regulated and henceforth must comply with the licensing standards and requirements in this Order;

WHEREAS, the Bago City Health Office, located at A. Gonzaga Street, Barangay Poblacion, Bago City, Negros Occidental, under the Local Government of Bago City shall be established and will comply with the set guidelines and the minimum standards and requirements for licensing primary care facilities;

NOW, THEREFORE, on the motion of SP Member Jake Patrick Y. Torres, unanimously seconded by SP members present, the Sangguniang Panlungsód

RESOLVES, as it is hereby resolved, to establish the Bago City Health Office and Its Application for Department of Health-Permit to Construct (DOH-PTC) and Department of Health License-to-Operate of a Primary Care Facility (LTO PCF) Accreditation and Licensing thrd the Health Facilities and Services of the Department of Health.
