

WHEREAS, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to approve the said budget.


NOW, THEREFORE, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sanggunian
