RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND ON BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT BETWEEN THE CITY OF BAGO AND THE PHILIPPINE AIR FORCE (PAF) IN RELATION TO THE IMPLEMENTATION OF REPUBLIC ACT 9163 (NATIONAL SERVICE TRAINING PROGRAM ACT OF 2001) WHICH FORMS PART OF THE CURRICULA OF THE BACCALAUREATE DEGREE COURSE AT BAGO CITY COLLEGE.


WHEREAS, in a letter dated March 23, 2023, from the Acting City Mayor, Honorable Ramon D. Torres, and addressed to this Honorable Body, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and on behalf of the City of Bago in a Memorandum of Agreement between the City of Bago and the Philippine Air Force (PAF) in relation to the implementation of Republic Act 9163 (National Service Training Program Act of 2001) which forms part of the curricula of the baccalaureate degree course at Bago City College;
