**RESOLUTION NO. 23-116**

**RESOLUTION APPROVING THE CREATION OF THE PEOPLE'S COUNCIL IN THE CITY OF BAGO.**

**WHEREAS**, in an Indorsement letter dated March 23, 2023, from the Acting City Mayor, Honorable Ramon D. Torres, and respectfully referred to this Honorable body, the letter request of Engr. Deny L. Millevo, Asst. City Assessor/CSO Desk Officer-Designate, for the passage of a resolution approving the creation of the People's Council in the City of Bago;

**WHEREAS**, Article 62, Rule XIII of the Implementing Rules and Regulations (IRR) of the Local Government Code of 1991 (Republic Act 7160) mandates Local Government Units to promote and establish an operation of non-government organizations, people's organizations, and private sector to make them active partners in the pursuit of local autonomy, and to directly involve them in planning and implementation of programs and projects in the LGU;

**WHEREAS**, Section 6.2 of DILG Memorandum Circular 2021-054 encourages all cities and municipalities to create and institutionalize the People's Council which shall be composed of the representatives from the CSOs in the locality, whether accredited, registered, and recognized by their respective LGUs;

**WHEREAS**, after a thorough deliberation on the matter, the member of this Honorable Body is of the consensus to favorably act on the said request;

**NOW, THEREFORE**, upon motion of SP Member Victor Michael A. Javellana, unanimously seconded by SP Members present, the Sanggunian

**RESOLVES**, as it is hereby resolved, to approve the creation of the People's Council in the City of Bago.
